Bumbo Seats

All Incline Sleepers

are no longer considered safe for babies to sleep in.
Therefore, you may only sell items at JBF in which
babies lie FLAT to sleep.

All Crib Bumpers

are no longer considered safe and cannot be sold at
JBF.

Infantino Infant Carriers

Go Forward 4-in-1 Evolved Ergonomic,
Flip Front2back, and Up Close Newborn infant carriers
were recalled in February 2020 due to buckles which
can break, posing a fall hazard.

for replacement options.

B.O.B. Strollers

BOB jogging strollers manufactured between January 2009 and September 2015 were recalled for front wheel attachment issues. The replacement thru-bolts are also faulty (model number is S11393700). The bolt can fracture during use, allowing the front wheel of the stroller to detach, posing a risk to the child in the stroller and the adult pushing the stroller. There is no current remedy offered by the manufacturer that makes this item safe to sell at JBF.

Maclaren Strollers

All Maclaren single and double umbrella strollers sold between 1999-2009 were recalled for potential finger amputation from hinge mechanism. Consumers should immediately stop using these recalled strollers and contact Maclaren USA to receive a free repair kit. Strollers with repair kit installed are safe to use and to sell at Just Between Friends.

Step2 Push Around Buggy

The yellow knob pin can become loose and allow the handle to separate from the buggy. Affected buggies have pins with yellow plastic knobs on the back of the buggy attaching the handle to the buggy.

Contact Step2 to request a repair kit. Buggies with repairs installed are safe to use and to sell at JBF.

If the handle of your buggy attaches with a bolt and screw, you have a new design and your buggy is not involved in this recall.

Baby Einstein Activity Jumper

The "sun" toy attachment on the activity jumper can rebound with force and injure the infant, posing an impact hazard.

Go to www.kidsii.com to request a free replacement part. Once this fix is installed, it is safe to use and to sell at JBF.

Summer Infant Baby Bather

When the bather is lifted and/or carried with an infant in it, its folding wire frame can suddenly disengage from the side hinge.

Bathers with FIVE rivets are recalled. All others are safe to use and to sell at JBF.

Chicco Polly High Chairs

This recall involves a range of Chicco Polly highchairs with pegs on the back legs intended for tray storage manufactured prior to October 13, 2010 and sold from 2005 through July 2012.

Contact Chicco to request a free peg cover kit. Once this fix is installed, it is safe to use and to sell at JBF.

CAR SEATS: WAIVER REQUIRED

All Car Seats must be checked for recalls before selling at JBF.

A completed **Car Seat Waiver is required** for all car seats, booster seats, and bases.

CRIBS: WAIVER REQUIRED

All Cribs made before June 28, 2011 are no longer considered safe for infants.

For cribs manufactured on or after this date:
a completed **Crib Waiver is Required.**



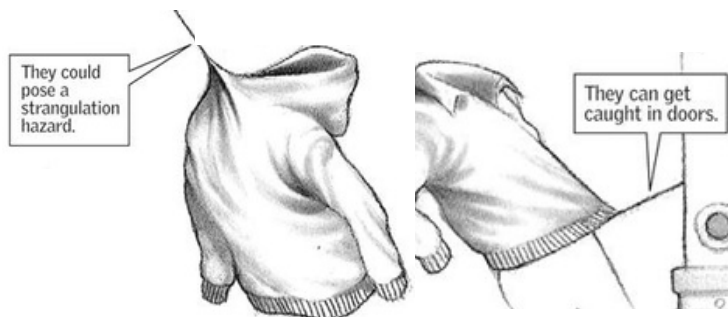
HELP STOP TIP OVERS



All furniture over 27-inches
will be sold with safety straps to anchor
furniture to the wall safely.

We will provide safety straps for your
items when you drop it off at the JBF sale.

DRAWSTRING SAFETY



Upper Outerwear WAIST Drawstrings
should be 3-inches or shorter and sewn
to garment at mid-point so string cannot
be pulled to one side.

Upper Outerwear NECK Drawstrings
should be removed completely.

Car Seat Safety Checklist Questions	Circle answer and follow instructions.	
1. Are you the original owner of the seat?	Yes – Continue	No – Destroy Car Seat
2. Does the seat have a label with the date of manufacture and the model name/number?	Yes – Continue	No – Destroy Car Seat
3. Is the car seat expiration date one year or more from now?	Yes – Continue	No - Destroy Car Seat
4. Has the seat been recalled for a safety defect?	Yes – Continue to #4b	No – Continue to #5
4b. Has the defect been remedied?	Yes – Continue to #5	No – Destroy Car Seat or Remedy then Continue
5. Has the seat been involved in any vehicle crash (even a minor one)?	Yes - Destroy Car Seat	No – Continue
6. Are there any cracks, bends, or breaks in the plastic shell?	Yes - Destroy Car Seat	No – Continue
7. Is the metal frame rusted, bent or broken?	Yes - Destroy Car Seat	No – Continue
8. Do you have a copy of the manufacturer's instructions?	Yes – Continue	No – Obtain new instructions, then Continue
9. Does the seat have all of its parts including harness straps, harness clip, seat cover, tether, padding, shield and bolts?	Yes – Continue	No – Destroy Car Seat or Obtain replacements, then Continue
10. Are the harness straps worn or frayed and/or have the straps ever been washed in a washing machine?	Yes – Destroy Car Seat or Obtain replacements, then Continue	No – Continue
11. Have the car seat and/or straps been cleaned only per the manufacturer's instructions?	Yes – Continue	No – Destroy Car Seat or Contact Manufacturer to verify integrity has not been compromised, then Continue
12. Does the buckle or any other metal part show signs of rust?	Yes – Destroy Car Seat or Obtain replacements, then Continue	No - Continue
13. Is the car seat clean with no visible stains, holes, or tears?	Yes - Continue	No – Clean and repair or Destroy Car Seat
14. When buckled, does the mechanism lock securely and remain locked when in use?	Yes – Complete bottom portion to consign car seat	No – Destroy Car Seat or Obtain replacements then complete bottom portion to consign car seat

In order to sell a car seat please read, verify and sign the following:

I am the original owner of the car seat that I am selling through Just Between Friends Children's Consignment Sales Event and verify that it has never been in an automobile accident, has not been broken in anyway, has all of its parts, contains the identification label and is 1 year or more from expiration. I verify that the car seat has not been recalled to the best of my knowledge and if so, has been corrected to meet Motor Vehicle Safety standards. I verify that the car seat has all its harness straps, harness clip, seat cover, padding, shield and bolts and that the locking mechanism locks securely.
